

Speech of H.E. Fabrizio Marcelli Ambassador of Italy to Lebanon Beirut, 07 January 2025

Public procurement done right can attract much-needed international investment, promote fair competition, and drive sustainable growth.

Over the past months, this program has brought together dedicated professionals who have deepened their expertise in procurement laws, international best practices, and principles of sustainability and integrity. Their journey was not just academic—it was a step toward becoming leaders in their institutions, capable of ensuring accountability and driving positive change.
